## How Canada Uses Psychiatry for Political Purposes

*In Soviet style, Canada uses psychiatry to silence and discredit political dissenters and human rights activists. As a case in point, doctors at Hotel Dieu Hospital in Kingston, Ontario, have coordinated their actions with those of the Kingston Police and have debased their professional standards and codes in order to throw doubt on Kevin Galalae's ability to reason and therefore discredit his human rights activism and parenting abilities.*

Between May 15 and 18, Hotel Dieu Hospital in Kingston, Ontario, kept me against my will for a psychological “assessment” on the insistence of the Kingston Police. No tests were performed, no medication prescribed and no treatment of any kind was given to me during this 72-hour so-called assessment period. I walked the hallways, stretched out the meals, made puzzles, watched TV and talked to other patients in order to pass the time. Save for two 15 minute interviews with Dr. Scott, I was ignored by the medical staff. My so called assessment was clearly just a way to detain me while the police planned my arrest, which is indeed what occurred only two hours before I was to be released from the hospital.

I have described the hospital’s many violations of due process and of my rights in the article *The Man Inside: Incipient Totalitarianism in the Western World*.<sup>1</sup>

In this article I will dissect the report the hospital released<sup>2</sup>, which stands in stark contradiction to the two independent psychological assessments I underwent shortly after my release from prison in order to prove my mental health.<sup>3</sup> What is evident from the onset is that the hospital’s report is a complete fabrication, as it is full of inaccuracies and blatant lies. As such, the report in no way reflects my mental health. It does however reflect the dysfunctional state of the psychiatric profession in Kingston, Canada, and the ease with which psychiatrists are coerced by the police and the political establishment to pervert their professional standards.

Before I proceed to show the negligence and perhaps even unscrupulousness of those who produced the report and the speciousness of its findings, it is worth noting that the hospital held it back for nearly two months and that it released it only after I demanded an internal investigation and threatened a lawsuit if the report was further delayed. The events and timing preceding the release of the report are as follows:

1. **May 15 to 18:** I am held against my will, without medical justification, on the authority of an intern with no expertise in psychiatry<sup>4</sup> and am denied access to the patient advocate at the Hotel Dieu Hospital’s psychiatry ward (Johnson 3).

2. **June 8:** I send Janine Schweitzer, the hospital's Chief of Quality, Risk Management and Corporate Education, a "Summary of Events" which is an early version of the article **The Man Inside**, and ask that the hospital issues an apology for the way I was treated.
3. **June 10:** Janine Schweitzer calls to tell me that she asked the hospital's Psychiatry department to start an investigation. She expresses her shock at the events I described in my article and promises to get to the bottom of it. I thank her promptly:

4. **June 11 to 27:** Despite several calls over a period of two weeks to inquire if the investigation was concluded and if so what are its findings, as well as to ask that the hospital issues its assessment of my condition since many parties were asking for it, I did not receive any conclusive answer from Mrs. Schweitzer other than telephone calls informing me that the investigation is ongoing and she has no results to report to me.
5. **June 28:** Tired of waiting and of being given the run-around every time I asked the hospital's record office why my assessment has not been issued, I send Mrs. Schweitzer an email asking why the investigation has not been concluded and send her copies of my two independent medical reports as well as a copy of my article **The Man: Turning the Tide**<sup>5</sup> in the hope that this would speed up the process.

Dear Janine,

Three weeks have gone by since I first contacted you with my request. I have yet to receive either the results of the investigation or a copy of my patient record. Since tomorrow is my judicial pre-trial, this poses problems for me. The absence of my psychological report will most likely give the police an excuse not to drop the charges against me. This will mean three more months of legal costs until my case comes to trial.

To speed up the process, I am sending you two independent psychological assessments and a copy of an article I wrote recently detailing my accomplishments during my protest and hunger strike in Europe, the very hunger strike that some of Hotel Dieu's psychiatrists have used against me because, to quote my F42 Form:

*"physician has certified that he/she has reasonable cause to believe that you have shown or are showing a lack of competence to care for yourself and that you are suffering from a mental disorder of a nature or quality that likely will result in serious physical impairment of you."*

I hope to hear from you soon and I hope for good news.

Dear Janine,

The Program Medical Director needs to give this issue due attention. Every day delayed translates into another day I cannot see my children, so you can imagine how crucially important this is for me.

By all means, forward the documents I sent you to the Program Medical Director. By the way, the police are now looking for a way out of the mess they have landed themselves in. There will be a lot of blaming and scapegoating now that careers are at risk. At the judicial pre-trial today the judge told the police and Crown that they have no case and that in fact, I quote, their case is “shitty”.

I would also like to inform you that I have secured a human rights lawyer. He found my case so compelling that he took the case on contingency pay and he cannot wait to go after the police. You should also know that I have engaged the Human Rights Tribunal due to the political dimension of the case.

Last but not least, I have informed the European Court of Human Rights in Strasbourg that there may be a connection between my outstanding lawsuit against the UK and the malicious and discriminatory way in which I was treated upon my return to Canada. It is my guess that within weeks there will be a lot of parties involved in this case and that it will acquire an international dimension and perhaps a lot of publicity.

The time to act for the hospital is now.

7. **June 30 to July 7:** There is no news from the hospital, either on the psychiatric report or the investigation.

8. **July 8:** I receive the hospital's conclusion of its investigation. The letter is dated July 4 and, despite the disgraceful manner in which my rights were violated and professional codes ignored, Dr. Milev, the man who wrote the letter, finds no fault with the way I was treated by the medical staff.

10. **July 13:** I receive the long-awaited report in the mail.

The hospital's *discharge summary* is fraudulent in all respects and was issued to give the Kingston police what they wanted and to protect the hospital from a lawsuit for the doctors' failure to abide by their profession's standards and due process.

Here are its many flaws:

1. It states that my referring physician was Dr. Armita Rahmani. This is false. The referring physician was Dr. Oliver, a fact confirmed by the hospital's staff itself on the 16<sup>th</sup> of May.<sup>6</sup> Why the name of the referring physician should have changed can only mean that Dr. Dijana Oliver could not be coopted to put her name on a fraudulent report and the hospital administration had to find a more pliable doctor. Dr. Armita Rahmani came to the rescue.

2. Under the heading “history of present illness” the report states: “*History obtained from collaterals and the patient revealed that the patient had a history of paranoia for the last few years.*” Who these collaterals are, however, is not mentioned, which indicates that my alleged history of paranoia is based on my wife’s statements and Detective McCarthy’s, who herself received all her information from my wife. The sentence also implies that I confirmed my alleged history of paranoia, which is patently untrue. The report then continues to assign a series of behaviours and actions as evidence of my alleged paranoia. Most disturbingly, the report uses the distorted language of a paranoid person to mislead the reader into believing that I am the source of such language and that I must therefore be paranoid:

*“He complained that he has a feeling that the British Government was controlling what can be taught and said in school. Also, he further mentioned that the powerful forces were watching all his online activities and that these powerful forces are also reading his emails and putting things in his computer. He further added that his phones are tapped and there are spies in his classroom.”*

Hundreds of pages of evidence on Wikispooks and Cryptome show that what I have stated from the very beginning is that the Government of the UK operates a covert program of surveillance and censorship of the academic environment. I have provided abundant evidence to this effect and have analysed the reasons and objectives of this program in a series of published articles<sup>7</sup>. What I have stated in respect to the surveillance of my electronic communication is that my computer has been cyber attacked on at least two different occasions and that on one occasion my entire hard drive was wiped clean. What I have also stated is that my computer has been infected with malicious spyware and that as a result of such attacks I lost two computers and have had to debug my last computer several times in order to keep it operational. These are not delusions they are hard cold facts that can be corroborated by my computer expert, Mr. Dennis Wallace, who carried out all the repairs and made the diagnostics. As to spies in the classrooms, once again the record is clear. In my article *The Great Secret: Surveillance and Censorship in Britain and the EU*<sup>8</sup> I have described how the Government of the UK embeds agents in online courses and that these agents masquerade as common students but collaborate with the course tutors to monitor and censor the debates according to the dictates of CONTEST, *The United Kingdom's Strategy for Countering International Terrorism* (<http://www.official-documents.gov.uk/document/cm75/7547/7547.pdf>).

3. The report then states with complete disregard for the facts: “*The patient was quite distressed with these feelings, which made him go to the RCMP thinking that his life was in danger. The police then brought him to the Emergency Department.*”

As anyone who has read my detailed account of the events prior to my first incarceration will know<sup>9</sup>, it is not I who went to the RCMP but the Kingston Police who came to me. In my account I describe how Constable Gemignano picked me up at the movie theatre and misled me into believing that if I agreed to a psychological investigation I would be free to go in a few hours. Once I was locked in the back of his cruiser, however, he changed his story and informed me that the hospital has the right to hold me up to 72 hours. At no time during my interviews with the police or the medical staff did I say that my life is in danger. This, once again, is a complete fabrication intended no doubt to create the impression in those who read the report that I am paranoid and delusional.

4. The report continues: “*The patient complained of poor sleep, low mood, and poor appetite to the point he lost 20 lbs in the last six months. He denied any thought racing. He appeared grandiose in conversation.*” Once again, not a single word is true in this sentence. On page 29 of my article ***The Man Inside: Incipient Totalitarianism in the Western World***, I describe how I corrected Dr. Scott when he read from the patient file that I have problems sleeping and asked me to confirm this. That this incorrect observation should reappear two months later in the discharge summary and after I specifically corrected Dr. Scott is clearly not a mistake but a conscious lie intended to create fictitious evidence of physical symptoms typical of paranoid delusional patients. As for my mood, it was not “*low*” but angry and disappointed, as anyone would be considering my wife’s betrayal, the manner in which the police brought me into the hospital and the way in which the hospital held me against my will, without due process, and without medical justification. The most ridiculous inaccuracy, however, is that I had “*poor appetite*” and “*lost 20 lbs in the last six months*”. Dr. Scott clearly did not do his homework. The reality is that I was ravenous and wanted to eat constantly since I had just finished a 30-day hunger strike in France. The gradual way in which I lost the weight is carefully documented in four of the six articles I published during the hunger strike<sup>10</sup>. Had Dr. Scott bothered to read them he would have avoided

embarrassing himself in public by issuing his disgraceful report. Having lost 20 kg between April 12 and May 12, and having recommenced to eat on May 12, by the time I reached Canada I could not stop eating and I was putting on weight by the hour. While in the hospital I was constantly hungry and I complained several times to the nurses that I was not getting enough food. Of course, Dr. Scott needed to say that I had poor appetite in order to fabricate medical evidence that nothing was right with me. Dr. Scott's statement that I "*appeared grandiose in conversation*" is as inaccurate as his observations about my appetite, mood and sleep patterns and intended, once again, to create the illusion that he had observed symptoms in me that are typical of delusional patients. First of all, I never had a conversation with him, just two short interviews where he asked me a few questions and I gave him concise answers. Both interviews were 15 minutes long and he spent most of the time writing not talking to me.

5. More fabrications appear in the "*family history*" section where it is stated that my sister "*has post traumatic major depressive disorder*". Where Dr. Scott received this information is a mystery to me. My sister lives in Florida and is an American citizen. Not only is this alleged diagnosis a blatant lie, it would have also been impossible for Dr. Scott or any other doctor in Canada or in the US for that matter, since medical records are private and sealed, to access this information even if it existed. This means that Dr. Scott states as certain hearsay from third parties, which in this case could only have been my wife. And we all know by now how creative my wife is with the facts. Of course, Dr. Scott needed to create a family history of psychiatric problems in order to link my sister's alleged depression with my episode of depression some 20 years ago when my then fiancée left me and I was heartbroken. My episode of depression is mentioned by Dr. Scott under the heading "*past surgical history*", where he also admits – no doubt reluctantly – that I have "*no past hospitalization due to psychiatric reasons*" and that I have "*sound physical health*".
6. Under the heading "*course in hospital*" more contradictions appear in the hospital's report. It states: "*On the first day of his hospitalization, he presented himself as a polite, respectable individual. He was very passionate about ideas and passionate about his children. He was put on a Form 3 after expiration of Form 1. He denies suicidal and homicidal ideation.*"

Yet despite my perfectly normal appearance and the reality that I am a polite and respectable individual, the hospital's multi-axial diagnosis, further down in the report, gives me a GAF score of only 60 on admission and 70 on discharge, which though not a flattering score it certainly proves that there was no medical justification for holding me against my will in the hospital. For that I would have had to score well below 50. This contradiction demonstrates

that the hospital held me against my will and without medical justification because the police had asked them to and not because there was anything in my behaviour or mental health that warranted it. The **Global Assessment of Functioning (GAF)**, for those who are unfamiliar with it, “*is a numeric scale (0 through 100) used by mental health clinicians and physicians to subjectively rate the social, occupational, and psychological functioning of adults, e.g., how well or adaptively one is meeting various problems-in-living.*”<sup>11</sup>

7. The most egregious lie in the report is that I “*was started on Olanzapine prn 5mg q6h prn for sleep and agitation*”. I never received and I never asked for any drugs for the duration of my stay in the hospital. And I certainly did not need any sleeping drugs since I have never in my life had any sleep disturbances. Four hours prior to my release from the hospital on the 18<sup>th</sup> of May I was given a single Vitamin B1 pill because my blood test showed I had a slight deficiency, no doubt due to the prolonged hunger strike I had been on. Beyond that I was not medicated and I would not have accepted medication since I am adamantly opposed to the Western culture of pharmacological abuse. Why Dr. Scott would lie on record about my allegedly having received Olanzapine is beyond me.
8. The report also states that a “*CT scan of head was ordered to look for medical causes.*” What medical causes a CT scan was to uncover is of course not specified since this is just more hot air from the medical staff at Hotel Dieu Hospital. As expected, no CT scan was performed, as there were no tests whatsoever performed.
9. Solid proof that the hospital held me without medical justification comes from the fact that no psychiatric medications of any kind were prescribed or even recommended at discharge.
10. Despite the fact that no psychiatric medications were prescribed at discharge, that no medications were administered to me while in the hospital, and that no tests whatsoever were performed to determine my mental state, the hospital’s diagnosis is one that would strike horror in any patient’s heart and that should have required a treatment plan, were it true. It reads as follows:

Axis 1 – Delusional disorder

Differential diagnosis:

1. Hypomania secondary to bipolar disorder
2. Hypomania secondary to personality disorder

Axis 2 – Narcissistic trait

Axis 3 – None

Axis 4 – Marriage stresses

Axis 5 – GAF score on admission 60, on discharge 70

The diagnosis that I suffer from ‘delusional disorder’ is of course tailor made to mock my reasoning abilities and thus discredit my human rights activism and writings. It is also taken straight from the methods of political control employed by the former Soviet Union. The Serbsky Institute of Forensic Psychiatry in Moscow where Colonel-Doctor Lunts “treated” patients who suffered from political nonconformity during the cold war days is the model that now Canada is using to stifle its own political dissenters. While the methods are milder the purpose is the same and is aptly described by John Barron in his book **KGB**:

*“Under Brezhnev the KGB was allowed to inflict a convenient new form of punishment, ‘forcible treatment’ in mental institutions. The practice of locking up ideological deviants in asylums obviates the need for even pretending to observe formal legal procedures. Rules regarding length of detention, evidence, public trials, and similar “legalities” all can be discarded. By labeling a dissenter insane, the KGB creates at least some doubt about the validity of his or her complaints. By subjecting some political dissenters to drug tortures in the asylums and inflicting on them permanent psychological and physiological damage, the KGB doubtless discourages dissent.”* (p. 150, **KGB** by John Barron)

In the same fashion, Canada’s security apparatus confined me to a mental institution for 72 hours under a Form 42 with the intention of committing me to further 30 days, at the first sign of anger or weakness, under an assessment order under section 672 of the Criminal Code, which the Kingston Police, the police disclosure shows, had indeed requested<sup>12</sup>. In the absence of any evidence of aggression, mental instability or emotional weakness on my part the psychiatrists had no choice but to release me and the police’s plans to commit me to an insane asylum in Soviet style were foiled.

*“In Great Britain, 44 psychiatrists studied diagnoses made by KGB-controlled psychiatrists of 6 political dissidents. They judged that the Soviet diagnoses were made purely in consequence of actions in which the prisoners were exercising fundamental freedoms.”* (p. 51, **KGB** by John Barron)

In my case, the interviews I was subjected to by Dr. Murray and Dr. Flynn<sup>13</sup> show that my revelations in respect to Britain’s program of surveillance and censorship and my protest in France were used as “evidence” that I am delusional, even though the two doctors never read anything I wrote on the subject and were just paraphrasing information relayed to them by

Detective McCarthy. My right to freedom of speech and conscience in other words were put on trial by the psychiatrists at Hotel Dieu Hospital just two days after my return from France where the media was coerced to remain silent while I hungered for 30 days in defence of fundamental freedoms. In retrospect, it is clear that the reason my hunger strike was not reported by any of the media and was actively suppressed (and as such it now has the distinction of being the longest unreported and officially suppressed hunger strike in modern history), was because an attack on me was being prepared by the Canadian authorities (acting, no doubt, on a British request that I be silenced) and that such attack could only be carried out if I was unknown to the public.

Sakharov wrote in 1972: *“The use of psychiatry for political purposes is extraordinarily dangerous in its consequences for society and completely intolerable.”* The International Committee for the Defense of Human Rights in Paris reported that people were herded into KGB mental institutions for disagreement with official doctrine. The Soviet biochemist Zhores A. Medvedev wrote a book, *“A Question of Madness”*, about his “treatment” for “paranoid delusions of reforming society”.

My “crimes” are the same as those unfortunate dissidents in the former Soviet Union, namely disagreeing with official doctrine and attempting to reform society so that our fundamental freedoms are not robbed from under us and we will one day all wake up in a totalitarian state that herds any and all who dare say a word against the state or criticise officials who are above the law.

*“Periodically, the prisoner is offered renewed opportunity to renounce his beliefs and confirm his insanity. If he remains recalcitrant, drug therapy begins. While use of a variety of drugs has been reported, the most frequently mentioned are aminozin, sulfazin, and reserpine...”* (p. 54, **KGB** by John Barron)

While I was only threatened with drug therapy none was administered. Nevertheless, three months after my release from hospital, upon being forced to plead guilty for crimes I did not commit<sup>14</sup>, the Crown attorneys insisted that the judge adds in my probation order the condition that I subject myself to *“such assessment, treatment and counselling Programmes as directed by the Probation Officer, including but not limited to mental health.”* The judge complied despite the fact that I presented two extensive psychological reports which prove that I am perfectly healthy both mentally and emotionally.<sup>15</sup> They were of course duly ignored and only the Hotel Dieu Hospital report was considered. The condition that I am to subject myself to further mental health tests at the discretion of my Probation Officer, who is not a doctor and therefore lacks the necessary expertise to determine my mental health, serves as a continuing threat that I can be

committed to a mental facility and held against my will unless I cease and desist from criticising the Government of Canada and its allies or dare to once again expose secret and illegal programs or State violations of fundamental rights. It is in other words the Canadian version of the Soviet practice to offer patients/prisoners renewed opportunity to renounce their beliefs or confirm their insanity. To ensure that this is not the fate I meet with once I speak up again, I have presented my Probation Officer with a petition signed by nearly 40 individuals and intended for Canada's Minister of Justice. This is the text of the petition:

**IN DEFENCE OF KEVIN MUGUR GALALAE**

**PETITION TO CANADA'S MINISTER OF JUSTICE AND ATTORNEY GENERAL  
THE HONOURABLE ROB NICHOLSON**

We, the undersigned, object in the strongest terms possible to the way our son, brother, friend and colleague, Kevin Mugur Galalae, has been treated by the Canadian authorities upon his return to Canada from his hunger strike in France.

His arrest, incarceration, prosecution and conviction represent a gross miscarriage of justice and show malicious intent that can only be explained by a politically motivated attack on him. Worse than this, his separation from his children, for whom he has always been the main caregiver, is a crime against the sacred bond between father and son and is a blatant attempt to destroy Kevin's emotional wellbeing.

The continuing insistence that Kevin is "delusional" about the covert program of *surveillance and censorship* (SAC) of British universities that he has uncovered and exposed betrays an equally blatant attempt by the Canadian authorities to discredit Kevin's writings and his human rights activism. If Kevin is delusional about the violations of human rights and civil liberties in British and possibly EU universities then so are we because we believe that the evidence he has brought forth is sound and has been amply corroborated by the Universities UK's report "*Freedom of Speech on Campus: rights and responsibilities in UK universities*" and by more recent media reports about changes in the Prevent strategy. If there are inaccuracies in Kevin's analysis then they are the result of the conspiracy of silence and the culture of secrecy that have infected our society and government policies post 9/11. In the very least, the Canadian authorities must cease and desist any attacks on and insinuations about Kevin's mental health until such time as the Government of Canada or an international court of law commence a public inquest to determine to what extent Kevin's allegations about SAC are true or false.

We sign this statement of support to ensure that Kevin Mugur Galalae is henceforth treated with respect by the Canadian authorities and that his rights and liberties are safeguarded according to the Canadian Charter and international law. We also request that a higher court investigates the breaches committed by the Kingston police, the Crown and Hotel Dieu Hospital that have led to Kevin's wrongful conviction for domestic harassment and to his forced separation from his children.

Back now to the diagnosis the psychiatrists at Hotel Dieu Hospitals produced. Unable to make up their mind about my mental condition and dissatisfied with merely diagnosing me with ‘delusional disorder’, they have added two differential diagnoses: hypomania secondary to bipolar disorder and/or hypomania secondary to personality disorder.

These differential diagnoses have obviously nothing to do with my mental condition since I have never even remotely suffered from bipolar disorder. They are however a slap in my face as this is the diagnoses I assigned to my wife’s mental and emotional condition<sup>16</sup>. By turning the tables on me, Hotel Dieu Hospital buffered my wife from attacks on her mental health and therefore strengthened the coalition between the Kingston Police, Hotel Dieu Hospital and my wife; a coalition that is soon to face a lawsuit.

Under Axis 2, the hospital’s report determined that I have a narcissistic trait. While I freely admit to some narcissistic tendencies – but then again who doesn’t have them – I am certainly no pathological narcissist, as the report seems to suggest. What narcissist, for instance, would hunger strike for 30 days for the sake of obtaining redress for people he has never met, which is what I have done while in Strasbourg, France.

Had the medical staff at Hotel Dieu Hospital done their jobs in accordance with their profession’s standards and codes, and not in obeisance to the political establishment’s dictates and on police orders, they would not have committed me to a 72-hour psychiatric evaluation against my will on the false determination that I have “*shown or are showing a lack of competence to care for [myself]*” and that am “*suffering from a mental disorder of a nature or quality that likely will result in serious physical impairment of [me]*”.<sup>17</sup> If that was indeed the case, then how do the hospital’s psychiatrists explain that I travelled half way across the world on my own; fulfilled a series of bureaucratic requirements in a foreign language, French; secured hotel and apartment accommodation on a week-to-week basis in a city that is notoriously overbooked; learned the city of Strasbourg’s complex public transportation system in order to get around; communicated with the officials at the police prefecture, the Council of Europe and the European Court of Human Rights in French and English; daily explained to dozens of visitors to the European Institutions the reason and purpose of my hunger strike and did this in French, English, Romanian, German, Italian and Spanish; drafted the application to the European Court of Mr. John Bull Okboli in both English and German; wrote dozens of letters on my behalf and on behalf of five other demonstrators during the 32 days I spent in Strasbourg; made several

friends inside and outside the ranks of the European Institutions; published six well-researched and referenced articles at a frequency of 1.5 articles a week; issued letters to the public and pamphlets and handouts in several languages for anyone interested in understanding why I was on hunger strike; assisted my less fortunate fellow demonstrators with advice, blankets, food, juice, translations and live interpretations; continued to perform the tasks associated with my employment as writer/translator/researcher and did so without compromising the quality of my work; visited universities, schools, mosques, churches and newspapers to drum up public support; walked at least 10 km every day to reach the sight of my hunger strike, the Internet café where I worked, the print shop, and many other locations; sent nearly a thousand emails in one month to people across the world and to the representatives of the European Parliament; stayed healthy and active by taking vitamin-enriched fruit juice; and stayed in touch with the people I love in Canada, Germany, the US, Romania and India.

Are all these actions consistent with someone who lacks the competence to care for himself and who suffers from a mental disorder that will result in serious physical impairment? I should think not. Anyone who comes to such a flawed conclusion ought to have their heads checked. Paradoxically, the people who arrived at this flawed conclusion are the psychiatrists at Hotel Dieu Hospital and Detective Diane McCarthy whose specialty, she bragged in court, is criminal law involving people with mental illnesses. Since these people are no simpletons, I can only conclude that their actions are politically motivated and centrally orchestrated. No other explanation fits the bill.
