# SECRET CIA REPORT REVEALS CORRUPTION, DIRTY TRICKS TO USE ASIL NADIR'S COMPANIES FOR SECRET SERVICE UNDERCOVER OPERATIONS

Many documents were deliberately suppressed in court during Asil Nadir's 2012 trial in London. They would have embarrassed the authorities. They prove that Nadir had been framed by British and American intelligence agencies in a government campaign of dirty tricks, lies, the jailing of innocent men, and even murder, to cover up the fact that both governments had been secretly selling illegal arms to Saddam Hussein using Asil Nadir's companies.

The most damning is a leaked secret CIA report from 1991. The report shows that the plot was widespread and made fortunes for those involved, including politicians and senior business men. When it looked like being uncovered, the spooks resorted to murder and framing innocent men to try and hide the truth. Along with the innocent directors of Matrix Churchill, this included the controversial Asil Nadir, whose Polly Peck International business empire was deliberately ruined by the British government with the loss of £2 billion, according to the sworn testimony of two undercover police spies who confessed that they were ordered to frame the tycoon by London's Serious Fraud Office acting in collusion with the Metropolitan Police. Nadir's trial was rigged.

#### **NOT A FORGERY**

All the expert evidence indicates that the CIA report is genuine. It matches the highly redacted copy released under the US Freedom of Information Act. (FOIA)

#### CIA'S SECRET INTELLIGENCE SUMMARY

The unredacted report is in two parts: a description of the murdered Dr Gerald Bull's 'Super Gun for Iraq' project, many of whose facts are already in the public arena. The explosive part of the CIA document is in a secret 'Intelligence Summary'. In the official FOIA released copy this has been completely redacted and blacked out. This newly leaked full copy reveals why.

### THE SMOKING GUN

The CIA report is a smoking gun pointing to widespread and official sponsored corruption, and illegal UK and US government activity. The CIA's revelations are extremely damaging to the British and US governments of the day and their intelligence agencies. The CIA names individuals and reveals details of covert illegal arms deals with Iraq, government policy, and companies involved in breach of national and international agreements. These secret arms sales appear to have made millions for politicians and their families. The report confirms other allegations of government corruption.

#### NAMING NAMES AND MURDERERS

The report also identifies UK intelligence agents coordinating illegal activities and arranging murders, false arrests and imprisonment of innocent men on behalf of the British government. It identifies one Stephan Kock as an undercover MI6 agent

charged with manipulating the media and arranging arrests on trumped up charges. It also reveals evidence of the Thatcher Conservative government lying and covering up at the highest levels in Parliament. Most damaging of all it confirms that several high profile murders of those involved in the Supergun affair and in arms deals with Iraq (for example the Gerald Bull murder in Brussels and Defence Journalist Jonathan Moyle's supposed 'suicide' in Chile) were in fact organised by MI6 and the SAS on government orders using an ex-SAS Colonel, Ian Jack.

# THE POLLY PECK SCANDAL

The CIA report also explains why tycoon Asil Nadir was arrested and his PPI company brought down deliberately by the UK's Serious Fraud Office (SFO) in 1990 - because the UK government had been secretly using Nadir's companies *without his knowledge* to carry out illegal arms trading with Iraq. After being charged with theft supposedly from his own companies, seeing his business empire ruined by fraudulent claims and government-inspired accusations that he had tried to bribe the judge, Nadir fled to northern Cyprus in 1993 because he became convinced he would not get a fair trial. The scandal was so wide-reaching at the time that the then Conservative Minister of State for Northern Ireland, Michael Mates, was forced to resign over his links and support of the businessman.

### **RIGGED CHARGES**

Nadir returned voluntarily to the UK in 2010 but was convicted on 23 August 2012 for seven thefts supposedly committed between August 1987 and June 1989. He was sentenced to ten years imprisonment. He has always claimed that the charges against him were rigged and that the SFO tried to frame him, abused its powers and doctored evidence, making any fair trial impossible. Evidence that was suppressed by the British government, using 'Public Interest Immunity Certificates' (PIICs) backs his claims.

### EVIDENCE OF GOVERNMENT AND SECRET SERVICE ACTIVITY

The CIA report confirms many of the allegations made in other documents, such as the sworn confessions of two police spies and numerous other suppressed documentary evidence. The CIA report specifically states, 'Subsequently Kock arranged the arrest of ... Asil Nadir, via the UK Serious Fraud Office'. Since then, two undercover police agents have given sworn statements in which they confess that they were bribed and blackmailed to lie and frame Nadir on direct orders from the Serious Fraud Office and the Metropolitan Police. However the UK government's continued use of 'Public Interest Immunity Certificates' to hide key evidence, gag defence witnesses and the courts' insistence on reporting restrictions and a complete news blackout in the UK, raises serious questions of the fairness of Nadir's trial.

# NEED FOR AN INDEPENDENT ENQUIRY

The documents suppressed by the Government clearly show that Asil Nadir did not receive a full and fair trial. These new revelations of government skullduggery, out of control spooks, secret murders and illegal arms trading go to the heart of the Thatcher government, the CIA and MI6. They also reveal a reckless disregard for the law by both governments and raise questions about Britain's deep state and the reliability of Asil Nadir's trial. Nadir appears to have been framed by the British government. Whether Asil Nadir stole from his companies or not, he did not receive a full and fair trial ...
