This refers to your *Privacy Act* request of September 1, 2011, received in our office on September 6, 2011 for access to personal information banks CSIS PPU 015 - <u>CSIS Records</u>, CSIS PPU 045 - <u>CSIS Investigational Records</u>, CSIS PPU 70 - <u>Passenger Protect Program – Specified Persons List</u>, and PSU 901-<u>Access Request Records</u>.

Based on information contained in your request, please be advised that personal information banks listed below were searched on your behalf with the following results:

CSIS PPU 015

<u>Canadian Security Intelligence Service Records</u> - A search of this bank was conducted and no personal information concerning you was located.

CSIS PPU 045

Canadian Security Intelligence Service Investigational Records
- The Governor-in-Council has designated this information bank an exempt bank pursuant to section 18 of the *Privacy Act*. If the type of information described in the bank did exist, it would qualify for exemption under section 21 (as it relates to the efforts of Canada towards detecting, preventing or suppressing subversive or hostile activities), or 22(1)(a) and/or (b) of the *Act*.

Passenger Protect Program - Specified Persons List - Access to this bank is refused pursuant to subsections 16(1) and (2) of the *Privacy Act* since any personal information, if it existed in this bank, could reasonably be expected to be exempted by virtue of one or more of sections 19(1), 21 (as it relates to the efforts of Canada towards detecting, preventing or suppressing subversive or hostile activities), or 22(1)(b), 25 or 26 of the *Act*.
