My name is Sharyn Bovat & I'm the NISSAN Whistleblower.

Because I was born into a family that was known for being in the intelligence community I believe that is why NISSAN executives have bullied, jailed, slandered, harassed, and **now** it looks like former CIA that were connected to drug trafficking, people most likely connected to the Lockerbie cover-up- who are members of the American Bar Association conspired used the judicial system of the State of Tennessee to discredit me. I'm requesting a racketeering investigation, retrial and other remedies - that is why your getting this letter.

While working in relocation for NISSAN North America I discovered and reported to a NISSAN Motors board member issues of discrimination, corruption and wasteful spending of American taxpayer money (the was money they were taking from a Dept. of Energy loan).

On the executive floor at NISSAN I learned that the CEO hired ex CIA an employee told me they were used to keep Ghosn "in control"... he knew them from Michelin. Later at NISSAN I was accused of using an alias while working at NISSAN-I responded that the name I was using was called a "married name." For the record the man I was married to for over a decade did NOT know I did research until NISSAN "outed" me - we're now getting a divorce and I'm losing custody of my child

After I whistle blew I was called into 4 meeting with 2 different HR leaders. Two on the executive floor with the VP of HR Mark Stout. He

offered me money to be silent. He asked me if he gave me a check would I tell Carlos Tavares (that is the board member that I whistle blew to) and I told him "yes". That response triggered 3+ years of retaliation.





# Nissan was took over 1.4 billion US tax dollars via the Dept. of Energy to build a car with outdated technology

**History**- In summer of 2008 I started working for Catherine Perez. She was the incoming VP of Purchasing. Some of her expenses were questionable an example is I was paid to locate spas for oxygen facials (she hated having dry skin). I asked if the spending was OK & HR did not mind her extravagant lifestyle that was supported by a cost center backed with taxpayer

funded money.

Later Catherine & I became friends. In 2009 the highest



level woman at NISSAN told me the company was having a severe cash flow problem. It was communicated to me the Dept. of Energy loan was to "pay the bills" - employees told me that the Leaf could not be a success the car really cost 63k-80k to build and that the battery would degregate quickly. Nissan can't afford to pay it back - collateral is a taxpayer backed IDB bond. An Obama bundler approved the loan.

I should mention that Catherine is the rumored former mistress of Carlos Ghosn the CEO. Evidently When they broke up she was put through a Harvard program then given the NISSAN North America job. Catherine "thought" I was cute and promised to help me get the job I

felt like I deserved- which was to be in charge of relocation. Tennessee is a Good Ole Boy society and they did not like me for questioning their "real estate" deals so if I wanted a decent job dating her at the time seemed - sensible. I saved her notes and gifts. For the record I'm not gay. All I wanted was a job.

In memory of my first bookday in the US

The percentage of women in management at NISSAN was 20.9% in 2006 and 10% in 2009. This data is from NISSAN's own statistics.

In spring 2009 when working for NISSAN board member Carlos Tavares I communicated problems: For example I told him in the winter of 2009 that the "Good Ole Boys" had put people in every division and they were going to fire the employees from California 1st- Mr Tavares stopped it from happening & it scared people in HR that he listened to me. They offered me money ONLY if I would not tell Tavares - I did the ethical thing & they bullied me. So I fought back by using my 1st amendment right & exposed their bad behavior on a blog.



NISSAN executive's swore out warrants and then hired a lawyer named Joe Baugh to "babysit" the DA for a 1st time misdemeanor.

After being jailed on "trumped up" charges I blogged about more issues (I knew they were trying to discredit/scare me) so I wrote that the CEO of NISSAN being connected to ex CIA - that were involved with drug trafficking. I've blogged that the Lockerbie bombing was NOT done by who was blamed. & that the Lebanese CEO of NISSAN will know WHO is responsible for the crash of Pan Am flight 103.

At anytime the court could have done a mental evaluation. The only time one was requested (judge denied) was when I blogged that "if Good Ole Boys" were the only thing offered in Tennessee than I would consider "switching teams" I guess that made the DA question my mental health NOT the CIA stuff. Later I blogged about a person connected to AI Gore who suggested I "date him"- my response was rude because I thought it was a joke-Later I learned had I dated the man that almost became President the charges most likely would have been dropped. Since 2009 - AI Gore was a big fan of my blog. I've learned my story is not weird it's just Tennessee. Please look at different court cases. The courts in Tennessee allowed this to happen.

while at the RNC convention a video of me was made saying the pledge of allegiance and later a wife of an Air





In 1998 I moved to the Netherlands for

3 years (I have no clue whether or not that move was calculated by someone?).

About a year ago from a man who worked at Boeing confirmed that the NISSAN CEO's dad was part of Operation Condor. Also after a forum at Georgetown University I told a guy from the DOJ my family was connected to Condor (That connection is very indirect) ... you should have seen the look in his eyes. OMG!!!

I'm sure that afternoon Eliana Davidson will remember my questions about cyber security. I have a court transcript showing that NISSAN made the "relocation consultant" the #2 security risk. They put me in the cyber system as a threat. That act "outed me" and terrified me.

#### **Brief History**

My grandfather Karl Frisbie started his career in naval intelligence: attended training in Princeton & lived in Korea in the late 40's. Nobody really knows what he did. He was a lawyer for the DOD and a triple dipper. I learned he was linked to Condor but I do not know any details.



My mom Carolyn Bovat lived in Tokyo in the 50's working as Chief stewardess for

Transocean Airlines, she trained women to spy for America. They were subsidized by the CIA. In the mid 80's her boyfriend a 747 captain for World Airways was known as the "gun runner" this is the Iran Contra era. He disappeared mysteriously later we found out he was not dead but in Panama City (he feared witch hunts). Later in December 1993 I was told my life could be in danger so I too disappeared (not to the extreme as him) but I left California all my friends just to be "out of sight-out of mind" I got married in the late 90's and never told the man my family was connected to the CIA.

ratting out spies/ friendly fixtures.





**More History-** The airline people in the 50's were a tight knit group.My family were just PILOTS. They did what they were told. We never became rich and never used connections to profit. Once again I do not know details about what they did. I know my dad flew flights in Laos & I met a Condor pilot when I was a child. I was with Ed Daly my dad's boss when he and "Ford's guy" were talking about the Vietnam war (Former President Ford had tacos with me backstage of the 1992 RNC convention in Houston).

In 1980 I attended a boarding school and was the roommate of a girl from El Salvador. Her family led death squads - remember the whacked priest? Her mom used jewelry from dead jews to pay for her Gucci purses. When I wanted a new purse I was told no and later sat on a flight next to a Holocaust survivor who talked the entire time about her ordeal.





In the mid 80's I was engaged to Tom Huffaker a divorce lawyer who "out of the blue" got into the foreign service. He did 2 tours in Moscow.

Also, in the mid 80's Nancy Reagan was worried that our top scientist would tell Russian spies secrets so I dated one - he was really smart named Glen McWright. He worked at the time at Lawrence Livermore Lab- he never talked about work and today "I Think" he's a top DOD Scientist working at DARPA & the NSA Liaison.

FYI- I do NOT trust the CIA due to the Brothers Preston.... are they "really" brothers?


FYI- Iran ordered it. that is my opinion & have facts to back it up.


## Subject: Death threat of sharyn bovat traced to church newsletter


#### **Request:**

Over 3 years of being bullied because I whistle blew & the ONLY thing I was found guilty of (& I still claim my innocence) is the lowest level misdemeanor that had a maximum penalty of \$50.

It's = to a speeding ticket. Occupy protestors in Tennessee were charged the same crime and SELECTIVE prosecution was done to me. Lots of Tennessee politicians have profited from "green" industries.

Most of my subpoenas were quashed 2 days before trial. My lawyer lied &/or was very unprofessional.



I've learned that racketeering is happening in Tennessee and I would hope it's being investigated. Recently the state comptroller for the state has found excessive reasons for concern. This issue is connected to the Tennessee ECD programs.


