Raymond John Ryan (January 9, 1904 in Watertown, Wisconsin – October 18, 1977) was an American professional gambler, oilman, promoter, and developer.

Described as having a larger-than-life personality, he mingled with prominent business people and movie stars, as well as with cardsharps and mobsters on his path to fame and fortune. His sensational murder case was never solved.

- Q. Was Harries one of the instructors at the CIA's mercenary school?
- A. Yes, he was.
- Q. What operations were you involved in around 1961/62 on behalf of the CIA and organized crime?

In 1961/62 1 was busily engaged in locating properties for the CIA, which could be used as a documentation center, a weapons modification center and a fixed base operation for planes we either owned or contemplated acquiring. At the same time, I was in partnership with Licavoli in a number of ventures, including an aircraft company and a military equipment procurement venture. Pete and I were also partners in art galleries in Tucson, Arizona, Detroit and Grosse Point, Michigan and Laguna Beach, California.
 - Q. How would you define a "proprietary interest"? Would the mob equivalent be a "front" business?
 - A. That is an accurate representation.
 - Q. In December of 1961, did you attend a meeting at Bermuda Dunes airport, near Palm Springs?
 - A. Yes.
 - Q. Who was at this meeting?
- A. Sam Giancana, Johnny Roselli, William King Harvey, Peter Licavoli, Ray Ryan, Frank Hayden and myself.
 - Q. What were the objectives of those in attendance?
- A. To lay out the method of operation for Harvey's resurrected ZR/Rifle program, which was renamed Operation Mongoose, the ultimate purpose of which was the assassination of Fidel Castro.
 - Q. What was your role at this meeting?
 - A. I served as secretary and took notes of the meeting.
 - Q. Did you feel that the mob and the CIA trusted each other?
 - A. Certainly not. Neither of these organizations trusted anyone.
 - Q. Would it be fair to say that 1963 was for you a time of stepped up activities?
 - A. Yes. 1963 was a very busy year.
- Q. In April of 1963 were you told by Philip Twombly that a special project was planned for the fall of 1963?
- A. I was told by Twombly that an incident would be created in the fall to inject some life into the anti-Castro campaign.
 - O. Was there any indication that this involved assassination or violence of any kind?
 - A. None whatsoever.
- Q Would you have been willing to get involved if assassination was contemplated?

- A. Not unless it was the assassination of Castro.
- Q. Did anything else of significance happen in April of 1963 that was of concern to you and your colleagues?

A. Yes.

The photocopies of documents in his book is very extensive and convincing and verifiable, and his story checks out in all ways.

He was a mercenary CIA fighter Soldier of Fortune and Special Activities Pilot of Fortune and Misfortune. Pilots like him and Barry Seal flying C-47's into Latin American loaded with CIA cash, weapons, or operatives.

Holt was developed inside the mob and then deployed as a contractor the the CIA Domestic Contacting Service or something like that as likely there are complex and changing ways the CIA accomplishes use of assets.

He has loyalty to his assignments and coworkers, a CIA litmus test and standard, and did not intend to kill JFK as was willing to offer information in an unfettered way but was involved in the activity that assassinated Kennedy as an operative lacking high level knowledge of the mission. His handlers requested he duck testifying in some maters and he did at times because of the requests and at other times as his own preference.

One truth he clearly leaves out is that Lansdale is there with him and likely the source of protection the Tramps are receiving.

Col Prouty and Lansdale and Charles Cabell (and likely James Paul Donegan) were likely flying missions together in 1952 and after under Richard Bissle Jr., so Holt leaving Lansdale out of the identifications was likely loyalty to Lansdale for the employment opportunity.

The two guiding figure fore Chauncey Holt are mob figure and strike breaker asset to Ford Motors Peter Licavoli met through Bud Holt and attorney Frank Belcher who was the intermediary to mob assets and made the necessary payouts to the mob for strikebreaking, etc.,

Holt states "On the other side of the fence, [mobster] Licavoli also continued to be deeply involved through the years with attorney Frank Belcher with whom he maintained a joint banking account at the Bank of America in Burbank."

Sometimes controversially various government forces use contractors like Blackwater, etc., and it is somewhat akin to Sherrifs, Marshalls, Deputies who are largely Enforcers using push to get some state of affairs in place in public places. This drifts at times as COINTELRPO of mob resources, the mob willing to break the law and thus pre-empt a threat like a strike against a company or future strike against the US Government.

Chauncey Holt in Self-Portrait: It was through Zwick's recommendation that I later gained an introduction to Peter Licavoli, one of the most important organized crime figures in America, who was a central figure in three of the most sensational murders in the first half of this century.

- 1) the killing of Jackie Kennedy, the so-called "beer baron of Toledo"
- 2) the murder of Jerry Buckley, a "crusading" radio announcer in Detroit, and
- 3) the infamous St. Valentine's Day Massacre in Chicago.

Years later, in Pete's declining years, we discussed these sensational crimes at great length.

Of course, I was well aware of who Licavoli was, since one of my cousins, Bud Holt, had worked for Harry Bennett, a most unusual gangster, who was chief of security for Ford in Detroit [as car making boomed].

Bennett worked hand in glove with Licavoli and other Detroit gangsters, using them as strike breakers. On the other side of the fence, Licavoli also continued to be deeply involved through the years with attorney Frank Belcher with whom he maintained a joint banking account at the Bank of America in Burbank, CA.

Many of Holt's CIA contract agent "projects" were funded and funneled through this special account.

In 1975 the CIA began to purge rogue contract agents, aka "cowboys" from its employ. Some were forced into retirement, while others like Chauncey Holt ended up in prison.

On January 2, 1976, Holt had written a letter to his old CIA ally William King Harvey apprising him of his recent indictment by a federal grand jury.

Harvey responded by saying he could only offer "token assistance." Harvey did offer to send Chauncey some CIA documents that were about to be declassified. These records proved that Holt worked for the Clandestine Operations of the Central Intel Intelligence Agency.

In 1977 Holt was convicted of mail fraud and sent Terminal Is- land, a federal prison. Prior to sentencing, he was offered a place in the Witness Protection Program and early release from prison by the Organized Crime Task Force for his testimony against Meyer Lansky and Licavoli. He refused to co- operate with them.

Representatives of the CIA promised Holt preferential treat- ment in prison and a "payoff" if he agreed to keep silent about his activities on behalf of the Agency. He kept his word, until the principals died.

Chauncey Holt died on June 28, 1997, eight days after completing this interview. He was 75.

Thomas "Yonnie" Licavoli (February 9, 1904 – September 17, 1973) was an American gangster and bootlegger during Prohibition. Born in St. Louis, Missouri, Licavoli, along with brother Peter Joseph Licavoli and cousin James Licavoli, worked with Jewish gangsters to take over illegal gambling in St. Louis. The Licavolis soon moved on to Detroit, Michigan and would control criminal operations in Detroit and Toledo, Ohio, throughout the Prohibition era.

The second of four children of Sicilian immigrants, Thomas Licavoli grew up in the Jewish slums of St. Louis. Licavoli's parents wanted him to become a Catholic priest, so he enrolled in Christian Brothers College High School in St. Louis to study for the priesthood. When he was 19, Licavoli was arrested for carrying a concealed weapon, and decided to join the US Navy rather than go to prison. However, soon after completing his basic training Licavoli deserted and became ensconced in gang society.

https://www.geocities.ws/pointplacehistory/kennedy.html [Because of its proximity to Detroit, Toledo was an evil and dangerous city during the late 1920s and early 1930s. The notorious Purple Gang led by Thomas "Yonnie" Licavoli was chased from Detroit and settled in Toledo. Prohibition gangsterism was at its height and Licavoli took over the rackets He established gambling spots, night clubs, and whorehouses while producing and importing all types of alcoholic products. (He had opened a bar on Edgewater called the Golden Rose.) Yonnie's men were especially vicious and there was very little resistance to the gunmen who were extortionists, strong arm robbers, bombers and basically terrorists.

The Murder of Jackie Kennedy (no Kennedy family connection)

One who did offer resistance was an Irish bootlegger and night club owner, Jackie Kennedy, from Toledo. He openly opposed Licavoli--even fought with and bested several of his men.

Leaving "Pumpkins" and his gun, Jack, in slippers, and Louise went up to Edgewater and walked along the road to 140th. They were eventually followed by some youths, William Hood and Donald McLeary. Robert Schwaite and Harry Craig watched them from a car parked opposite Erd Fish Market. Then a maroon-colored Ford stopped in front of the fish house. Two men got out of the car and starting walking after Jack and Audrey while the third followed along in the car. Then upon reaching the couple, they threw the girl aside and shot Jack with 12 dum-dum bullets resulting in 22 wounds mainly around the head and face.] https://www.geocities.ws/pointplacehistory/kennedy.html

The murder of Jerry Buckley

Gerald E. Buckley (April 5, 1891 – July 23, 1930) was an American radio commentator in Detroit, Michigan. He successfully campaigned for the recall of Mayor Charles Bowles in the wake of corruption allegations. Prior to his death, Buckley had served as an investigator for Henry Ford, and as a special investigator for the United States government.

Buckley served as an investigator for Henry Ford, owner of Ford Motor Company, during the 1921 Newberry v. United States Supreme Court case, in which Ford legally challenged his defeat to Truman Newberry in the 1918 US Senate Election.[7] Following his involvement in this case, Buckley continued to work as a government investigator on various legal cases, and occasionally channeled his investigative skills to aid his brother, George, in his legal work.[3][5][7][8] Buckley's lifelong passion for song composition, combined with his investigative background, led him to a career in broadcasting, where he would become one of the first media celebrities of the burgeoning new medium of radio in the 1920s.

In 1928, Buckley began hosting a 6 p.m. nightly commentary program on Detroit radio station WMBC.[10] [8] Since the imposition of Prohibition in Michigan in 1917, Detroit had become a mecca for criminal activity, with prostitution, gambling and illegal alcohol production and consumption running rampant in the hands of mobsters, resulting in frequent gangland killings.[11] Bootleggers operated extensively in Detroit, using nearby Windsor, Ontario as a conduit to funnel liquor illicitly into the US.[12] Broadcasting from WMBC-AM studios on the top floor of the luxurious LaSalle Hotel, Buckley used his platform to enact a campaign against the rampant and rising crime in Detroit.[11][13]

Buckley voiced the fears and outrage of his Detroit audience, whom he called the "Common Herd," openly criticizing and accusing city government officials of incompetence and attacking those whom he believed to be at fault for Detroit's rising crime rates.[3][5] Buckley also served as an advocate for his "Common Herd," lobbying for various social causes such as social welfare programs, old-age pensions and providing jobs for the unemployed.[5][14] This advocacy earned him his status as "the voice of the people" amidst the beginnings of the Depression Era, when unemployment figures skyrocketed in Detroit.[14][5]

The success of Buckley's radio career came at a price; although beloved by the masses, he was also subject to numerous threats for his uninhibited critique of illicit activities in Detroit.[3] When implored to hire a bodyguard to protect him, Buckley reportedly dismissed the suggestion, stating, "I get twenty threats a day. There is always someone who says I'll be killed."[3] Despite his joking, Buckley kept a room at the LaSalle Hotel for emergency scenarios, and allegedly refused to leave the hotel on multiple occasions out of fear for his safety.

On the night of the successful recall, Buckley was approached by three men and shot eleven times in the lobby of the LaSalle Hotel in Detroit, where WMBC's studios were located.

Following a funeral mass at St. Gregory's Catholic Church, Buckley was buried at Detroit's Mount Olivet Cemetery. The funeral had 150,000 attendees.

After his murder, Police Commissioner Wilcox alleged that Buckley was a known extortionist and racketeer who had likely been killed because of his underworld connections.[1] In his attempt to tarnish Buckley's reputation, Wilcox produced an affidavit stating that the slain radio commentator had been paid \$4,000 in "protection money" by a bootlegger. The affidavit was soon dismissed as having been coerced.[10] Buckley's brother Paul, a former assistant prosecutor, claimed that the murder was orchestrated as revenge for the campaign against the mayor.

Saint Valentine's Day Massacre

The St Valentine's Day Massacare is what I Ed Donegan have alleged since I lived in Casa Linda Apartments and appealed to Comey online to become a Capone shutting down genoracketeering and put Paperlace music in my book.

The Saint Valentine's Day Massacre was the murder of seven members and associates of Chicago's North Side Gang that occurred on Saint Valentine's Day 1929. The men were gathered at a Lincoln Park, Chicago garage on the morning of February 14, 1929. They were lined up against a wall and shot by four unknown assailants, two dressed as police officers.

The murders resulted from the competition for control of organized crime in the city during Prohibition between the largely Irish North Siders, headed by George "Bugs" Moran, and their largely Italian Chicago Outfit rivals led by Al Capone.[1] The perpetrators have never been conclusively identified, but former members of the Egan's Rats gang working for Capone are suspected of involvement; others have said that members of the Chicago Police Department who allegedly wanted revenge for the killing of a police officer's son played a part. - Wikipedia

Genoracketeering

In miss-tellings of events I am on a mission to "turn out" teens into domination, into Nazi white Hitler youth, or easy prey to peeping as I bottom feed. Protectors of the scene will make sure I am not an influence on the scene and blacklisted from it. The part that works is that I am far right and near Nazi views on race. I have always said and known since the 1970s the scene was very far left and mostly except a few of my age were both unwanted at and unwilling to go to sociology based movement culture.

I had thought and it is partly true the frame job on me as a dangerous pimp or peeper was politically motivated, or motivated by those hoping to make their name in scene ethics or policing, and the scene was not that much of a worry, concern, or interest to me, repeatedly deciding in my life I wanted little to do with it and greeted veterans instead, etc..,

The obvious smear machine engine is way beyond politics though and I think tied to illegal programs of Targeting Gunderson and others have experienced.

I had also at times made decision to get back into BDSM organizations and social networks but have been harrassed and blacklisted like at Jim Volcelka, and again, even in private apartments not connected to the scene at all. While I am harassed in everything, in nothing so much as my book writing, and that I think is the real government concern with me, the rest just undercutting what would be supportive relationships I would have had to complain too about covert harassment.

The harassers of me gave themselves a pretext to harrass me (some of them real) and asked the community to mob against me. Much of it is smear but since Black lives Matters amnd similar movements have so much support, child porn plants or ostracism is accepted against the alt-right, but the FBI and CIA, and by the public.

This goes beyond ostracism though, and as I and Sosbee and Gunderson and Labella and Cooper assert this is about organized crime, racketeering, and thugs.

This is not to say I don't hold or express opinions on Goth, Cybergoth, or anything else. I have noted in 2005 or so many older goths such as myself were less enthused about globalism, and felt pressured by the world crushing in on them. I also believed that Cybergoth was active all around the Western Hemisphere including in Eastern Europe, and felt we should not split with the Americas nor Eastern Europe, Anne Coulter long distrusting Hispanics. I have come to believe since Hispanic immigrants are a crime threat and that is just alt right life and beliefs and in my case experiences.

Feelings though are not what I am discussing. Faking cases against me (obstruction of justice in the manufacture of injustice to me) is one crime and I assert a crime in furtherance of destroying a witnes to the Kennedy Assassination and contemporary figures, agencies, and people who have ties to CIA subversion

plans laid in the 20th Century to awaken in the 21st Century with them in power as the elites, elites now covering their trail secretly.

As a matter of tactics the CIA and US DOD usually conduct dubious operations (like framing me) in such a way as to make the victim (me) look bad. Say some little old lady dents your Mercedes with a cat food and then lays down in front of it with her groceries spilled into the street shouting help I have been it by that car.

Those framing me as using children as visual porn are dancing around as illegal immigrants in bizarre acts singing "Nacho Nacho Man. I want to be a Nacho Man!" as I accuse them of being migrant criminals. The reverse psychology is I look I am trying to undermine their credibility because of their race, holding an unjust establishment entitlement that fails to erode their righteous acts of catching a child pervert. That someone would try to undermine their goodness with racism makes me look bad.

As always this reverses who I actually am. When I spoke to the Secret Service did I mean to kill Barrack Obama Jr? No. As I said then it would have been tactically a bad thing in public perception and comparative worth, and I also thought it would be wrong to undermine a historic achievement long awaited, and would not want such a crime ever from any camp I am in. IN fact I was torn between Macain and Obama anyway.

Ray Ryan and Palm Springs and I think Grace Ranch implied in movie Misfits

In the 1950s and '60s, Ryan was a land developer in Palm Springs, California. Real estate development in Palm Springs did not generate much interest until actor Clark Gable built a home there. Ryan joined with 24 other investors to purchase the run-down El Mirador Hotel in Palm Springs. After restoring it to its former elegance, he bought out his partners in 1960.

In the Marilyn Monroe movie hints are left towards pressurized cockpits, refrigerated moving propeller engine parts, bombs that can be loaded and unloaded for B-29s on patrol not bombing missions, and changes to the P-51 Mustang to a faster higher altitude motor.

Might have been a Howard Hughes lab similar to Santa Susanna Field Labs.

The movie featured both Clark Gable and Marilyn Monroe and I assert the CIA killed them both.

Towards the end of his career, Pete moved to Tucson, Arizona, becoming one of Arizona's wealthiest men. Licavoli purchased large amounts of land and commercial property in Tucson, including the Grace Ranch in honor of his wife Grace Bommarito. Grace Ranch served as the Licavoli family headquarters and became a safe haven for the mob for over 35 years. From Tucson, Licavoli set up the southwest gambling wire and supervised his Detroit rackets.

Even with his millions of dollars stored away, Pete couldn't resist the urge to sell a stolen painting to an undercover FBI agent. It was a small painting with a low value, but Licavoli was a man always looking to move stolen property. He was tried by a federal judge in Tucson and given an 18 month sentence, a small penalty considering the US government had been trying to put him behind bars without success for over 25 years.

After a long career with the Purple Gang and a mere five and a half years spent in prison over his criminal career, Licavoli's health began to deteriorate.[5] He had cancer in remission and an inflamed liver. On January 11, 1984, at the age of 81, Pete Licavoli died of a heart ailment in his home in Tucson, Arizona. In his obituary, he is described by Senator Estes Kefauver as "one of the most cold blooded and contemptuous characters to appear before their committee." - Wikipedia
