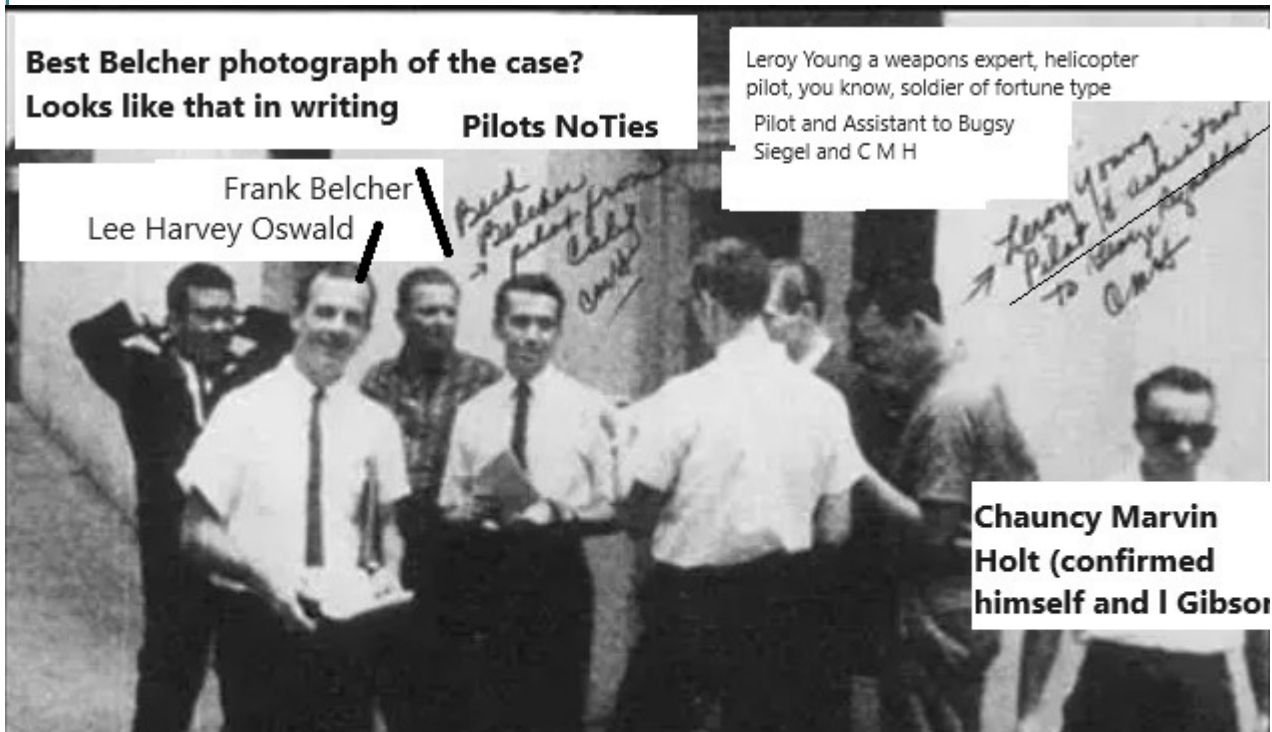


## If We Are To Believe Chauncey Marvin Holt's Handwriting On This Photo ...

Frank Belcher, Larry Young, and Chauncey Marvin Holt as mob Pilots and Muscle. No ties worn. Lee Harvey Oswald is passing out Fair Play For Cuba fliers in New Orleans at the FBI Office of Naval Intelligence FBI Federal Building with Reily Coffee a CIA proprietary (front company) interest of the CIA. The hope is for Lee Harvey Oswald to infiltrate Cuban communist groups or Russia as an FBI Double Agent.

Frank Belcher is the payroll person who operates out of a California bank to pay for the printing of fake *Fair Play For Cuba* fliers and other activities. The artist, painter, and forger Chauncey Marvin Hold designed the fliers printed at Los Angeles Stamp and Stationary Company. They had upper floors of the building reserved for CIA work.

The mob was already smuggling booze and engaged in assassinations, etc., and could be used for arms smuggling, etc., in Latin America.

Here is how it all came about. Two Mobsters (Chauncey Holt and Peter Licavoli) have relatives. Bud Holt (Cousin of Marvin Holt) and Peter Licavoli has the brothers Joseph and Yonnie Licavoli. At least one of the Licavoli

The story of the CIA activity takes the reader behind the scenes of deep cover operations. Holt shows how his identity as Jack Moon was created. He shows how someone checking into his background would discover that he was an MIT graduate (he never attended the school) and a classmate of George Schultz. He was also registered as a Certified Public Accountant in the state of Massachusetts.

The documentation mills of the CIA are covered, as well as an explanation of the proprietary interests of the company. The Bay of Pigs fiasco involved Holt in his capacity with the International Rescue Committee. The IRC role was logistical, arranging for the ships, hiring pilots from the Alabama National Guard, and engaging in other, related roles. Operation Mongoose followed the Bay of Pigs and resulted from the Kennedy brothers' obsession with destroying Castro. The Bay of Pigs was an Eisenhower administration operation they inherited, but the brothers took the defeat personally. They did not have so strong a desire to defeat Castro as they did to win whatever they tried.

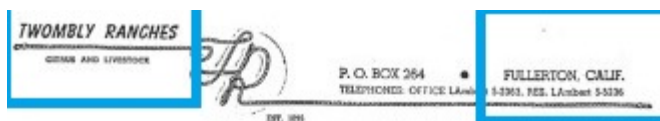
The roles played by William King Harvey, Robert Maheu, Sam Giancana, and Johnny Rosselli have been well publicized. However, the roles of some of the other players, including Peter Licavoli, friend and long time associate of both Rosella and Giancana, as well as Tony Materna, a close associate of Howard Hughes, legendary gambler Ray Ryan and his partner, Ernie Dunlevie, have never before been exposed.

It was also this plot that ultimately was a probable factor in the assassination of Jack Kennedy. In presenting the information on the CIA, either within the text or in an appendix, Holt will include a list of the CIA fronts active in California during this period as well as background concerning their "legitimate" and covert reasons for existence.

Holt will also discuss some of the CIA covert operations such as the assassination of Rafael Leonida Trujillo, one of the most vicious butchers ever to operate in the Caribbean.

Aspects of the Kennedy assassination are discussed. At the time of the murder, Holt was working for KG & Co. The "K" stood for former California Governor Goodwin Knight. The "G" stood for Alfred Gitelson, a sitting Los Angeles County Superior Court Judge.

Among the many partners in the company were Frank Belcher, Joe Ball, and Doc Stacher. The combination of political clout from the named partners, and the money of the organized crime relatively silent partners, led to tremendous profits, often at the expense of the taxpayers. The conduit for all CIA operations in California and Arizona was Phillip Twombly, former executive vice president of Coca Cola, the eyes and ears of the CIA in the Caribbean, who owned the University Bank of Fullerton, California.



April The first letter that Holt received from his CIA superior Phillip Twombly regarding the "special order" from the "distributor" in New Orleans to fabricate fake identifications for Lee Harvey Oswald. This distributor was Guy Barnister, who handled Lee Oswald along with other CIA controllers like David Atlee Phillips.

Peter Licavoli's criminal career was not limited to the financial sphere. Licavoli also pleaded guilty to conspiracy to bribe a federal customs officer. Judge Edward J Moinet sentenced him to two years in prison and a \$1,000 fine. This was the first crime Licavoli had been convicted of. Licavoli's guilty plea came after an undercover government agent and one of the former customs officers that Licavoli was accused of bribing provided damaging evidence: Licavoli had paid Shell Miller, a former customs border patrolman, \$200 and three bottles of whiskey in 1928 to allow his liquor boats to arrive protected from Canada.

Bud Holt (cousin to Chauncey Holt) was a Ford employee working with Harry Bennet to suppress union problems via roughians and the mob, the mob muscle coming from mobster Peter Licavoli.

Harry Herbert Bennett (January 17, 1892 – January 4, 1979), was a boxer, naval sailor, and businessman. From the 1920s through 1945, he worked for Ford Motor Company and was best known as the head of Ford's "service department", the company's internal [Pinkerton-like] security agency. While working for Henry Ford, Bennett's union-busting tactics made him an enemy of the United Auto Workers (UAW) trade union. He gained infamy for his involvement in activities such as in the Battle of the Overpass, a 1937 incident where UAW members protesting for higher wages were assaulted by Ford security guards.

Harry Bennett was born in 1892 in Ann Arbor, Michigan. He went to common schools. As a youth, Bennett started competing in boxing and won some city bouts. He served in the U.S. Navy during World War I.

In the early days of Ford Motor Company, a security department operated under the name of the Ford Service Department. It was to try to control the growing labor unrest and suppress the emerging labor unions. Ford had instituted a policy called "speed up", by which the speed of the assembly lines was increased slightly every week, and employees were feeling the strain. The labor issues sometimes led to violent clashes between Ford's management, the police, and some workers. Henry Ford needed someone able to handle rough situations as head of his Service Department.

Bud Holt a Ford employee and cousin of Chauncey in a Senate hearing spoke about events that took place within the Ford Service Department in 1935. He claimed Pete helped recruit employees to "take care of certain trouble". [union busting and strike breaking] According to Bud Holt, Peter Licavoli later demanded higher wages for his recruits, which would in turn lead to his financial benefit. Bud Holt said Licavoli also forced Ford's Personnel Director, Harry Bennett's, car off the road after Bennett fired Licavoli's recruits. However, Holt denied this claim during the hearing. Additionally, Peter Licavoli was questioned during the Investigation of Organized Crime in Interstate Commerce by the Kefauver committee in 1951.

### **Orleans Parish, United Fruit Company base of operations for the CIA and Dulles Brothers, and the Caribbean home to Murder Inc., backing up United Fruit Company**

Holt, discussing the violent end of the Kennedy administration, which will be covered in the book states: "In early 1963, our Los Angeles documentation mill was the *Los Angeles Stamp and Stationery Company* (LASSCO). Tony Materna, a MIT graduate (for real) and formerly a close associate of Howard Hughes, was the general manager who supervised the day to day operation of the legal side of the business. I was in charge of the covert section, supervising the graphic artists responsible for turning out some of the best documents in the country for the CIA and organized crime.

"It was in April of 1963 that we were informed that a major project was contemplated for the fall of that year. Later we were instructed that an incident would be created during visits by President Kennedy to either Chicago, Miami, or some other large city. The incidents were to be viewed as the work of pro-Castro Cubans so that the CIA could regain interest in ridding the nation of Castro. (Oddly, at this time John Kennedy was subtly trying to bring Castro into a more positive relationship with the United States while his brother, Robert, was working on ways to assassinate him.)

"For this project, the covert section of LASSCO was asked to be prepared to forge identity documents for several agencies. The work, to be done on short notice, included documents and Japel recognition plns for the Secret Service. "In August of 1963, acting on instructions of George Reynolds, who operated the Atchafalaya Labor Camp in Morgan City, Louisiana, Bud Belcher and I flew to New Orleans. Bud was the son of Frank Belcher, owner of Belcher Aircraft, a CIA

proprietary interest. Bud and I were to give Lee Harvey Oswald material to distribute in his role with "Fair Play for Cuba."

The pamphlets we printed at LASSCO were passed to Guy Bannister, but there was a well-publicized arrest of Oswald at this time and, to the best of my knowledge, the material was never distributed.

### **Operation Mongoose moves on to the assassination of JFK under William King Harvey**

"In November I went to Dallas as instructed with forged documents for Homer Echevarria, as well as two men identified to me as Richard Montoya and Charles Harrelson. J was instructed to remain in Dealey Plaza 'in a support position' until after the motorcade and the planned demonstrations were finished.

J assumed that these were the fraudulent pro-Castro demonstrations discussed earlier in the year.

"As soon as the shooting started, I realized that I was another pawn in this operation. Montoya, Harrelson, and I took refuge in a boxcar, which had been identified to us as part of a train ready for departure. If anyone checked, they would have found that we were Alcohol, Tobacco, and Firearms (ATF) agents working in plain-clothes, the reason false documents had been prepared.

"An hour and a half after the shooting, we were arrested. We were taken to the Sheriff's Department command post and turned over to a deputy sheriff. Because of who we could 'prove' we were, we were turned over to Gordon Shanklin, FBI agent in charge. He released us almost immediately, not bothering to record our detainment. The closest to a record is a photograph that was taken of us as the 'three tramps' whose identities have been incorrectly speculated.

"Suddenly after the release of the movie JFK and the resulting publicity, including lengthy articles in Newsweek and elsewhere, the Dallas Police came up with what purports to be arrest records of the three tramps. However, there are no pictures or fingerprints of these three individuals, even though the Dallas Police Department now claims that they were held for four days for vagrancy and for theft.

The finger has been pointed all these years at the Dallas Police Department and the Federal Bureau of Investigation who, allegedly were well aware of documentary evidence that would blunt the criticisms of negligence if, in fact, it was in existence and not fabricated solely for the purpose of discrediting other individuals, including myself.

Holt will be identified in Dealey Plaza Photos as a Hobo who escaped into a Railroad car with Charles Harrelson and others, General Edward Lansdale is with them, and the operation was begun in 1962 that included printing fake Secret Service identification documents and other tasks such as acquiring rifles of various types funded by Belcher.
